Team Fees Poll

Results of the team fees poll were presented. It is basically a 50/50 split preference. There was a long discussion of the benefits of either version – team fees vs. individual fees – of funding our leagues. Ultimately, it came to a vote, and it was determined to continue to focus on individual player fees rather than team fees.

League Spending

Recently, there has been some spending that did not align with the preferences of the board at large. There was some discussion about guidelines and rules we could create; none were decided on at this time, but this will defer to the President and a small group to reconsider how to spend for league boards vs. members and how much of the funding should be spent on board events.

Volleyball Saving Plan

The plan proposed providing a sort of savings account to purchase equipment as needed instead of all at once. The proposal hit an issue with our bylaws; this discussion was tabled to be handled by the finance committee to discuss the best ways to propose a bylaw revision for how we allocate funds.

Volleyball Administrative Structure

There is uncertainty about the W+ league and why it is structured differently for volleyball than some of the other sports. There was discussion of how to create a regular structure for all sports to adhere to, but no final decisions were made. The volleyball board will revisit themselves to investigate which administrative structure will work best for them.
